1. Copy of **NOTORIZED** Medical Release Form (2 pages) for current year which is on file with your county agent for 2009
2. Copy of current 12 month negative Coggins Test for Equine Infectious Anemia (current through last day of show) (Horse's name must match that on entry form)
3. Copy of current / completed 4-H eligibility card on every horse entered (for each horse / exhibitor combination) and card must verify all horse or pony information, pony height, Short Stirrup and/or Little Britches status if appropriate.

**\*\*\*Note:** The horse=s name must be the same on all components of the entry including Entry Form, Eligibility Card and Coggins Test\*\*\*
